



Privacy Policy

This Privacy Policy describes the policies and practices of JAMIAK INC., d/b/a Boundery, regarding Personal Data collected on its website, i.e., www.shop.Boundery.com (the "Site"). "Personal Data" refers to personally identifiable information about You (such as your name, birth date, e-mail address, IP address or mailing address, phone number and any other information that can be used to identify or contact you).

This Privacy Policy is periodically updated. Please check back on a regular basis for changes. This Privacy Policy is effective as of January 23, 2020.

1.0 What information do we collect?

We collect information from You when you register on our Site, place an order or subscribe to our newsletter.

2.0 Personal Data Collected

The only Personal Data that BOUNDERY.COM currently collects is the data that You voluntarily provide to BOUNDERY.COM for its services. There are several places on the Site where you may enter Personal Data to receive products or services from BOUNDERY.COM.

3.0 Shipping Information

You must enter your first and last name, postal address, city, state, zip, country and phone number so that we can ship Your order. You can also enter Your company name.

4.0 Billing Information

You must enter your first and last name, postal address, city, state, zip, country and phone number so that we can process Your order. You can also enter Your company name.

5.0 Payment Information

You must enter Your credit card number, the CVV, the type of credit card You are using and the name on the credit card so that we can process Your payment. BOUNDERY.com does not store credit card information. If you pay through PayPal® please consult PayPal's Privacy Policy. If you pay by credit card, We use the services of a third party to process payments and credits. Please see stripe.com's Privacy Policy regarding its Privacy Policy. We do not store Your credit card information.

6.0 What do we use Your information for?

Any of the information we collect from You may be used in any of the following ways:

•To process transactions:

Your information, whether public or private, will not be sold, exchanged, transferred, or given to any other company for any reason whatsoever, without your written consent, other than for the sole purpose of delivering the purchased product or service requested.

•To send periodic emails:

The email address You provide for order processing may be used to send You information and updates pertaining to Your order and receiving company news, updates, related products or service information, etc.

Note: If at any time You would like to unsubscribe from receiving future emails, we include detailed “unsubscribe” instructions at the bottom of each email.

7.0 Non-Personal Data Collected

Data that does not qualify as Personal Data because it cannot be used to contact or identify You (“Non-Personal Data”) may also be automatically collected. For example, BOUNDERY.COM and its business partners may use technology to automatically collect Non-Personal Data about the use of the BOUNDERY.COM Site. This technology is used to track how many users access the Site, the date and time of their visits, the length of their stays, and which pages they view. We may also use technology to determine which web browsers You use. The information collected using this technology does not identify any user personally and is thus Non-Personal Data that simply enables BOUNDERY.COM and its business partners to compile statistics about users and their use of the Site. We use this Non-Personal Data and may share it with third parties to improve the content and functionality of the Site, to better understand our customers and markets and to improve our products and services.

8.0 3rd Party Advertising

We may use third party advertising companies to serve ads for us, using Non-Personal Data. These third parties may employ cookies and action tags (also known as single pixel gifs) to measure advertising effectiveness. They may also use this technology to serve specialized or relevant advertising content and/or recommendations to you on the Site or on a third party's website. Any information that these third parties collect via cookies and action tags is anonymous and does not contain any Personal Data.

9.0 What is a “3rd party ad network?”

Many of the banner ads displayed on web pages are not selected and delivered by the website visited by a consumer but by network advertising companies that manage and provide advertising for numerous unrelated websites. These companies are referred to as “**3rd party ad networks.**”

We may share Non-Personal Data and with 3rd party ad networks to improve the content and functionality of websites, to serve relevant advertising messages and measure advertising effectiveness, to better

understand our customers and markets, and to improve our products and services. Authorized 3rd party networks are contractually bound to secure the Non-Personal Data we transfer.

10.0 Do we use cookies?

Yes. Cookies are small files that a site or its service provider transfers to Your computer's hard drive through Your web browser (if you allow it to) that enables the site's or service provider's systems to recognize Your browser and capture and remember certain information.

We use cookies to help us remember and process the items in your shopping cart, understand and save your preferences for future visits, keep track of advertisements and compile aggregate data about site traffic and site interaction so that we can offer better site experiences and tools in the future.

11.0 Do we disclose any information to outside parties?

BOUNDERY.COM may disclose Personal Data to third parties if You have requested that we do so, or if it is necessary to provide you with the services you requested.

If BOUNDERY.COM is acquired by or merged into another entity, or all or a portion of BOUNDERY.COM's assets are sold or otherwise transferred to another entity, BOUNDERY.COM may disclose Personal Data to that entity. BOUNDERY.COM may also disclose Personal Data if required or authorized to do so by law, pursuant to a court order or to an industry reporting authority.

12.0 Third Party Links

Occasionally, at our discretion, we may include or offer third party products or services on our Site. These third-party sites have separate and independent privacy policies. We are not responsible or liable for the content and activities of these linked sites. Nonetheless, we seek to protect the integrity of our Site and welcome Your feedback about these sites.

13.0 Security Measures

Boundery.com takes reasonable precautions to safeguard Personal Data from loss, misuse, tampering, destruction and unauthorized access. While such security measures provide reasonable protections against unauthorized access, they do not guarantee that Your Personal Data will not be compromised.

14.0 Access

At Your request, BOUNDERY.COM will allow You to access or review your Personal Data and correct any errors. You may be required to provide identifying information and/or answer some security questions to verify your identity.

15.0 California Online Privacy Protection Act Compliance

We comply with the California Online Privacy Protection Act. We therefore will not distribute your Personal Data to outside parties without your consent.

16.0 Children's Online Privacy Protection Act Compliance

We comply with the requirements of Children's Online Privacy Protection Act so we do not knowingly collect any information from anyone under 13 years of age. Our Site, products and services are all directed to people who are at least 13 years old or older.

17.0 Links to Other Websites

BOUNDERY.COM may contain hyperlinks to websites that are not operated or controlled by BOUNDERY.COM. These hyperlinks are provided for your reference and convenience only and do not imply any endorsement of the activities of these third-party websites or any association with their operators.
